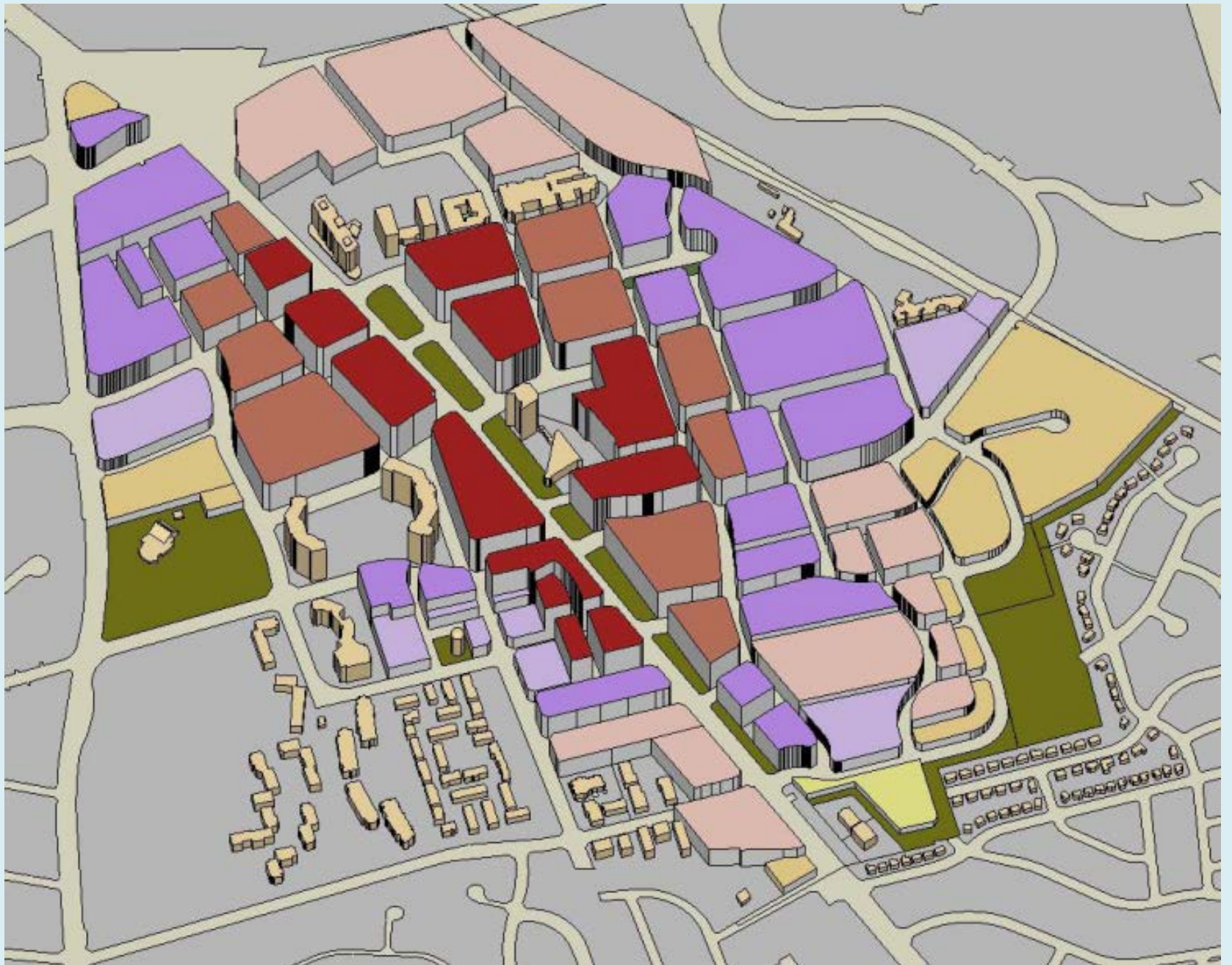
M White Flint Metro Station

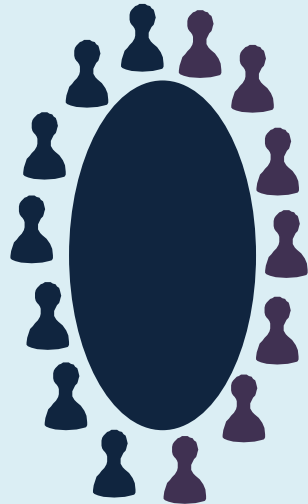
A-90 Master Plan of Highways Road #
